## Arrests

### Unbuckled Passenger Wanted and on Coke

09/26/05 at 3:41 am: Tommy Lee McGee, 50, of Waldorf; Phillip Lynn McCan Jr, 39, of Waldorf arrested.

TFC Linger initiated a traffic stop on Route 5 and Mt. Wolf Road, Charlotte Hall, because the passenger was not wearing a seatbelt. On contact with the driver, Mr. McGee, TFC Linger observed a plastic straw containing cocaine residue in the driver's side door handle. Mr. McGee was placed under arrest. A check through the National Crime Information Center was conducted on Mr. McGee and the passenger, Mr. McCan. Mr. McCan was placed under arrest for an open warrant in Charles County. A search of the vehicle incident to arrest was conducted. Another plastic straw, a ball of tin foil, and two plastic bags, all containing cocaine, were located. Both subjects were charged with Possession of Cocaine and Possession of CDS Paraphernalia.

### "Caution Crew" of Teeny Callers

09/24/05 at 8:00 am: Two juveniles, ages 13 and 14 from Leonardtown and one juvenile age 15 from Lexington Park were arrested and charged with Telephone Misuse after making numerous threatening phone calls to the victim. These juveniles claim to be part of a crew that calls themselves "Caution Crew". The juveniles were released into the custody of a guardian pending disposition by Juvenile Services. TFC Vanhoy, Bureau of Criminal Enforcement.
